Request for Quotation (RFQ)

For the Printing & Supply of Money Receipt (Aday Rashid Book) for CPSP of SDF Project Name: Credit Program Under Stimulus Package (CPSP)

- 1. The **Managing Director**, Social Development Foundation (SDF) has been allocated public funds and intends to apply a portion of the funds to eligible payments under the Contract for which this Quotation Document is issued.
- 2. Detailed Specifications of the calendar shall be available in the office of the Procuring Entity for inspection by the potential Quotationers during office hours on all working days.
- 3. Quotation shall be prepared and submitted using the 'Quotation Document'.
- 4. Quotation shall be completed properly, duly signed-dated each page by the authorized signatory and submitted by the date to the office as specified in **Para 6** below.
- 5. No Securities such as Quotation Security (i.e. the traditionally termed Earnest Money, Tender Security) and Performance Security shall be required for submission of the Quotation and delivery of the Goods (if awarded) respectively.
- 6. Your quotation, in duplicate, must be delivered to the office of the undersigned on or before 2.30 pm of 10th January, 2023. Any quotation received later than the scheduled time will be rejected and returned unopened. The envelope containing the quotation must be clearly marked "Quotation for the Printing & Supply of Money Receipt (Aday Rashid Book) for CPSP" of Social Development Foundation (SDF), 22/22, Khilzi Road, Mohammadpur, Dhaka-1207, and DO NOT OPEN before 2.30 pm of 10th January, 2023.
- 7. Quotations received by fax or through electronic mail shall be sealed-enveloped by the Procuring Entity duly marked as stated in **Para 6** above and, all Quotations thus received shall be sent to the Evaluation Committee for evaluation, without opening, by the same date of closing the Quotation.
- 8. The Procuring Entity may extend the deadline for submission of Quotations on justifiably acceptable grounds duly recorded subject to threshold of ten (10) days pursuant to Rule 71 (4) of the Public Procurement Rules, 2008.
- 9. All Quotations must be valid for a period of 30 (thirty) days from the closing date of the Quotation.
- 10. No public opening of Quotations received by the closing date shall be held.

- 11. Quotationer's rates or prices shall be inclusive of profit and overhead and all kinds of taxes, duties, fees, levies and other charges to be paid under the Applicable Law, if the Contract is awarded.
- 12. Rates shall be quoted and subsequent payments under this Contract shall be made in Taka currency. The price offered by the Quotationer, if accepted, shall remain fixed for the duration of the Contract.
- 13. Quotationers shall have legal capacity to enter into Contract. Quotationer, in support of its qualification, shall be required to submit certified photocopies of latest documents related to valid "Trade License, Tax Identification Number (TIN), VAT Registration Number and Financial Solvency Certificate" from any scheduled Bank; without which the Quotation may be considered non-responsive.
- 14. Quotations shall be evaluated based on information and documents submitted with the Quotations, by the Evaluation Committee and at least three (3) responsive Quotations will be required to determine the lowest evaluated responsive Quotations for award of the Contract.
- 15. In case of anomalies between unit rates or prices and the total amount quoted, the unit rates or prices shall prevail. In case of discrepancy between words and figures, the former will govern. Quotationer shall remain bound to accept the arithmetic corrections made by the Evaluation Committee.
- 16. The supply of Goods and related services shall be completed within 21 (twenty-one) days from the date of issuing the Purchase Order.
- 17. The Procuring Entity reserves the right to reject all the Quotations or annul the procurement proceedings.

- (c) after completion of the **Printing & Supply of Money Receipt (Aday Rashid Book) for CPSP of SDF**, the Supplier shall submit an original Invoice, and four (4) copies, to the Purchaser. The invoice shall show the cost of the preparation for Documentary including all VAT & Tax;
- (d) payment of the Invoice shall be arranged by the Purchaser, within twenty-eight (28) days, but only against the actual supplied quantities & qualities of the Printing & Supply of Money Receipt (Aday Rashid Book) for CPSP of SDF as list in the Purchase Order;
- (e) the Purchaser may, by written notice sent to the Supplier, terminate the Purchase Order in whole or in part at any time, If:
 - the Supplier fails to deliver any or all the Printing & Supply of Money Receipt (Aday Rashid Book) for CPSP of SDF within the time period(s) specified in the Purchase Order, or
 - ii. the Supplier fails to perform any other obligation(s) under the Purchase Order, or
 - iii. the Supplier, in either of the above circumstances does not cure its failure within a period of (3) three calendar days after receipt of a notice of default from the Purchaser specifying the nature of the default(s), or
 - iv. if the Supplier, in the judgment of the Purchaser, has engaged in any corrupt or fraudulent practices in competing for or in executing the tasks under this Purchase Order.
